Year-To-Year Budget Notes

Bancroft's initial formula allocation is \$9,936,070. This is an increase of \$1,125,140 compared to last year's initial budget allocation. School budgets are primarily driven by two key factors: enrollment and unique student need. In SY19-20, Bancroft's projected enrollment was 600. For SY20-21, their projected enrollment is 655, an increase of 55 students. At the same time, due to an increase in the number of students receiving special education services with more intensive needs, Bancroft requires 2 additional self-contained special education classrooms, resulting in an increased allocation of staff members and overall special education allocation. Additionally, due to an increase in the number of English Language Learners (ELL), Bancroft is receiving an increased ELL allocation.
