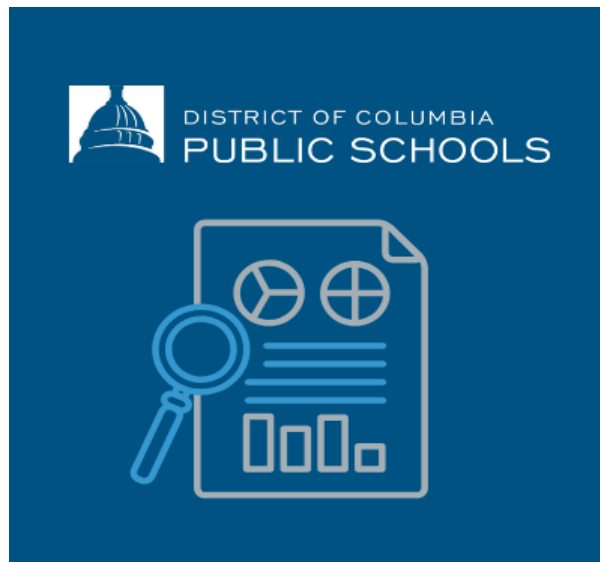

Year-To-Year Budget Notes

Brookland's initial formula allocation is \$6,283,206. This is an increase of \$1,148,474 compared to last year. School budgets are primarily driven by two key factors: enrollment and unique student need. In SY19-20, Brookland's projected enrollment was 311. For SY20-21, their projected enrollment is 401, an increase of 90 students. At the same time, due to an increase in the number of students receiving special education services with less intensive needs, Brookland requires an increase in the number of special education staff members, resulting in an increased special education allocation. Additionally, due to an increase in the number of English Language Learners (ELL), Brookland is receiving an increased ELL allocation.

Levels of Flexibility Key
