Year-To-Year Budget Notes

Langdon's initial formula allocation is \$5,846,550. This is an increase of \$787,767 compared to last year. School budgets are primarily driven by two key factors: enrollment and unique student need. In SY19-20, Langdon's projected enrollment was 368. For SY20-21, their projected enrollment is 419, an increase of 51 students. At the same time, due to an increase in the number of students receiving special education services with more intensive needs, Langdon requires 1 additional self-contained special education classroom, resulting in an increased allocation of staff members and overall special education allocation.
