Year-To-Year Budget Notes

School Without Walls @ Francis Stevens' (SWW-FS) initial formula allocation is \$8,203,990. This is an increase of \$1,040,770 compared to last year. School budgets are primarily driven by two key factors: enrollment and unique student need. In SY19-20, SWW-FS' projected enrollment was 495. For SY20-21, their projected enrollment is 587, an increase of 92 students. At the same time, due to an increase in the number of students receiving special education services with less intensive needs, SWW-FS requires an increase in the number of special education staff members, resulting in an increased special education allocation. Additionally, due to an increase in the number of English Language Learners (ELL), SWW-FS is receiving an increased ELL allocation.
