## Year-To-Year Budget Notes

Tyler's initial formula allocation is \$7,623,730. This is an increase of \$487,459 compared to last year. School budgets are primarily driven by two key factors: enrollment and unique student need. In SY19-20, Tyler's projected enrollment was 516. For SY20-21, their projected enrollment is 541, an increase of 25 students. Additionally, due to an increase in the number of students receiving special education services with less intensive needs, Tyler requires an increase in the number of special education staff members, resulting in an increased special education allocation.
